Chair William Cassidy determined that a quorum of Trustees was present and no requests from the public to address the Board of Trustees had been received, therefore, the meeting was called to order at 11:30 a.m.

ACCEPTANCE OF MINUTES

Resolution to Approve Minutes of Meetings

A motion was made and seconded to approve the Board of Trustee minutes dated November 18, 2020. The motion was unanimously approved to accept the minutes as presented.

A motion was made and seconded to ratify the Executive Committee minutes dated December 21, 2020. The motion was unanimously approved to ratify the minutes as presented.

Budget Planning – President Daigler provided an overview of the MCCS budget plans to the board. He outlined the implications of the budgetary options on staff and students. He also reviewed the work necessary to meet the current challenges presented. President Daigler discussed some new learning environments and the need to build Maine's workforce by providing training programs and building a pathway to a degree.

President Daigler presented the new Puritan video which provides one example of MCCS efforts to assist with meeting Maine's workforce needs. Financial support is critical to supporting the work the community college is undertaking.

Helen Pelletier then provided a short review of the 2020 Plan accomplishments and a review of the 2021 Strategic Plan draft identifying the proposed changes.

No action was taken by the Committee. The 2021 Strategic Plan will be presented for approval at the next board meeting.
